Sub: HIRING OF PRIVATE BUSES – Revision of Hire rates to buses introduced vide June 2013 Tender Notification and to Express type buses introduced as Replacement to old model buses of 2007 tender notification consequent to upward revision of HSD Oil price since June 2013 onwards - Reg.

The Corporation vide June 2013 tender notification invited applications from private entrepreneurs for supply of Bharat Stage–III 2013 Model Express, Metro Express, Pallevelugu and City Ordinary type buses under 'Hire Scheme' for operation on the identified routes. Consequent to this notification, around 192 buses were introduced so far.

Further, the corporate office vide Board resolution No. 39/2013 DT: 30.04.2013 resolved and accorded approval for allowing the existing owners to supply new model Express type hire buses as replacement to their old model Express type buses introduced in pursuance of tender notifications issued in the year 2007 at floor rates to be adopted in the tender notification of June 2013. Consequent to this resolution around 60 Express type buses were introduced so far.

Since, the rates of hire charges have to be revised along with the movement of price of HSD Oil as per the provisions of agreement entered into with the hire bus owners, it was informed vide reference (1) that the instructions pertaining to addition of difference of HSD price, increased since June 2013 to hire buses of June 2013 notification will be issued later.

The Committee reviewed hire rates payable to these hire buses and submitted its report recommending revision in hire rates payable, consequent to upward revision of HSD Oil price. VC & MD accorded approval for implementation of the revised hire rates as recommended by the Committee.

- 1. To increase the "allotted hire rates" of buses introduced vide June 2013 notification/Replacements to Express type buses of 2007 tender notifications as at Annexure (1) and Annexure (2) annexed overleaf.
- 2. The revised hire rates shall be endorsed in the agreements entered into by way of issue of an amendment duly acknowledged by the hire bus owners.
- 3. The payment of all hire buses bills shall be pre-audited.
