

CIRCULAR NO. 09/2015-OPD(P), DT. 22.10.2015.

Sub: FARES - Revision of fares in respect of certain types of Stage Carriages - Moffussil (Teluguvelugu, Express, Deluxe and Super Luxury, Indra, Garuda, Garuda+), City Services (City/Suburban Ordinary, Metro Express and Metro Deluxe) and General Bus Pass Tariffs - Reg.

Ref: 1) G.O.Ms.No.18, TR&B (TR-1) Dept., dt.03.02.2006.

2) G.O.Ms.No.19, TR&B (TR-1) Dept., dt.04.02.2006.

I. INTRODUCTION :

The Government of A.P. issued Orders vide G.O. 1st & 2nd cited permitting the Corporation to fix fares in respect of all types of stage carriages with a condition that fare increase shall be done judiciously keeping in view passengers concerns and carefully analyzing the impact on Occupancy Ratio of the Organization.

Corporation revised the fares during the year 2013 in respect of all types of services of all the Moffussil and City buses and issued instructions vide Circular 3rd cited.

Corporation realized Rs.4807.68 Crs from April 2014 to March 2015 against the expenditure of Rs.5402.80 Crs. Thus the loss incurred for the year 2014-2015 is Rs.595.12 Crs. Thus the accumulated loss of APSRTC as on 31.03.2015 is Rs.3168Crs and the total loans outstanding with Banks/Financial Institutions is Rs.2440Crs as on 30.09.2015.

Corporation has implemented Wage Revision to its employees with effect from April 2013 and the additional burden on APSRTC due to implementation of 43% fitment is around Rs.660 Crores Per Annum.

Considering all the above factors and Government Orders vide G.Os. 1st & 2nd cited, Corporation has decided to revise the fares in respect of Stage Carriage buses i.e., Teluguvelugu, Express, Deluxe, Super Luxury, Indra, Garuda and Garuda+ and all City/Sub-urban buses operated by the Corporation and different types of Bus Passes being issued to General Commuters, NGOs etc.

XII. INTER-STATE SERVICES :

The above revised fares are applicable to the services on inter-State routes also for the portion lying in Andhra Pradesh. The Depot Managers operating services on the inter-State routes on reciprocal basis with other STUs, are advised to send the copies of the revised fare table to their counter parts and ensure collection of uniform fares on those services. Further, care should be taken to ensure that there is no variation in the fare structure on the common sector of the routes operated by different Depots.

XIV: STUDENT BUS PASSES:

There is no change in the Student Bus Pass tariff both in Cities and Moffussil areas communicated vide Circular No. 21/2013 Dt.03.06.2013. Any revision in Student Bus Pass tariff will be communicated separately.

XV GENERAL

CAT CARD/VANITHA CARD:

- i) For Teluguvelugu services CAT Card fares are appended at Annexure- A.**
- ii) For special type services (Express, Deluxe & Super Luxury) the calculation of revised concessional CAT Card fare, is as follows.**

“The CAT Card fare shall be rounded off to next multiple of the rupee if the decimal portion of CAT Card fare arrived is 0.49 Ps or less and to the next higher multiple of one rupee if the decimal portion of CAT Card fare arrived is 0.50 Ps or above.”

XVI. CONCLUSION :



All the Unit Officers are hereby directed to take immediate action to prepare MTD 141 Cards and Fare-Tables for each service in accordance with these instructions.

The night-out services which start before 00.00 Hrs. of 23.10.2015 /24.10.2015 and continuing without break shall allow passengers on the old fares only, including the passengers boarding at intermediate stations.

Advance Reservations : The crew shall be advised not to collect the difference of fare from the Passengers who reserved their seats prior to revision of fares w.e.f 24.10.2015
