**Sub: APSRTC Logistics** - Transportation of Parcels and Couriers through APSRTC Logistics - Revision of tariff of Parcels & Couriers - Communicated - Reg.

APSRTC has entered into Logistics business from June 2016. Guidelines for collection of tariff is communicated from time to time vide circulars under ref. cited. It is proposed to computerize the logistics project.

At present the tariff of parcels is same for the distance above 300 kms. Now it is proposed to revise the tariff for every 100 kms after 300 kms upto 1000 kms and same rate above 1000 kms. The proposed tariff of parcels is shown here under

The tariff is inclusive of Hamali charges and Crew incentive

**Hamali charges** – It is proposed to pay Hamali charges as follows

**Crew incentive:** it is proposed to pay crew incentive @ 10% of Net revenue (Net revenue = Eligible parcel tariff – Hamali charges) subject to minimum of Rs. 5/- per consignment. No ceiling is fixed for motivating the crew to improve the parcel revenue.

**Courier Tariff:**

At present there are two types of courier tariffs for Inter State & Intra State irrespective of distance. Due to this, short distance courier senders may feel that the tariff is on high side. By considering the field problem, it is proposed to introduce additional slab for courier tariff up to 200 kms with in the State.

**Bulk transportation:**

To encourage bulk transporters, it is proposed to arrange dickey @ Rs. 3.50/- per kms/ton subject to availability of dickets.

**Contract booking:**

It is proposed to give roof top/dickeys on monthly contract @ not less than Rs. 3.50/- per km.

**Volumetric goods:**

It is proposed to calculate the volumetric items as follows

Take measurements of length, breadth and height and take the value of LxBxH. 2500 cubic centimeters shall be treated as 1 kg for items loaded in dickeys and 4000 cubic centimeters meters shall be treated as 1 kg for roof top items.

Example- length - 60 cms; breadth - 50 cms; height - 40 cms.

Then LxBxH= 60X50X40= 120000 cubic centimeters.

The weight as per measurement of box is  $12000/2500=48$  kgs for luggage loaded in dickeys and  $12000/4000=30$  kgs for the luggage loaded on roof top.

We will take actual weight & measured weight as per volumetric items and take calculation of tariff either actual weight/volumetric weight whichever is higher.

**Special Tariff:**

Special tariff is fixed to the following firms

1. HSRP - For HSRP (High Security Registration Plates) Rs. 65/- is fixed for 25 kgs parcel from Vja to various district HQs irrespective of distance and Rs. 35/- is fixed for 25kgs parcel from District HQs to various embossing centers within the District.
2. Acharya Nagarjuna University- Rs. 60/- for 25 kgs parcel and Rs. 100/- for 50 kgs parcel is fixed from Guntur to various places irrespective of distance.
3. Medplus - For Medplus medical boxes Rs. 70/- is fixed per box including door pickup at VJA irrespective of distance.
4. APSRTC CCS - For APSRTC CCS letters Rs. 11/- per letter is fixed to all places from VJA irrespective of distance.

This circular supersedes all circulars issued earlier in this connection.
