Sub: HIRING: Hiring of private buses – Revision of Tyres Cost for the hire buses introduced in 2007, 2008, 2009 and 2010 – Instructions for payment by way of adding it to prevailing hire rate - Reg.

It is to inform that provision is made in the Hire Tender Notifications issued in the year 2007, 2008, 2009 & 2010 for revision (increase / decrease) of the hire rates in line with revision in price (increase / decrease) of tyres and wages of drivers and cleaners. However the periodicity to review tyres cost is once in a year and wages cost will be once in two years.

A committee has been constituted to review the revision (increase / decrease) of rates of hire buses for notifications as indicated above in line with revision in cost (increase / decrease) of tyres. Recommendations of the committee are as follows:

- I. No enhancement in price of tyres for all types of buses introduced in pursuance of tender notifications issued in the year 2007 (6th year revision in 2013).
- II. No enhancement in price of tyres for PVG/Express type buses introduced in pursuance of tender notifications issued in the year 2008 (5th year revision in 2013) **except City ordinary buses by "01" paise and Metro Express buses by "02" paise (i.e., difference between prevailing cost of tyres in the year 2012 and 2013).**
- III. No enhancement in price of tyres for all types of buses introduced in pursuance of tender notifications issued in the year 2009 (4th year revision for the year 2013).
- IV. No enhancement in price of tyres for PVG type of buses introduced in pursuance of tender notification issued in the year 2010 (2nd year revision for the year 2013).

P.T.O

V.C & M.D with the concurrence of FA & CAO approved the above recommendations of the committee and ordered for implementation.

It is therefore requested to pay the following increase in hire rate (paise per KM) over the prevailing hire rate wherever applicable.
