#### I. INTRODUCTION:

Consequent to the fare revision w.e.f., 24.09.2012 vide circular cited at ref-2, the tariffs of Silver and Gold cards heve been revised. Revised slabs were communicated through the Cir cited at ref-4, duly dispensing the exemption given to the Silver & Gold Card Holders on collection of "Toll Plaza User Fee". As per the revised guidelines, "Toll Plaza User Fee has to be collected from the Silver & Gold Card holders while travelling in the bus wherever applicable.

### II. WITHDRAWL OF GOLD CARDS.

The performance of Silver & Gold Cards has been reviewed and observed that the sale of Gold Cards (Quarterly) are very less compared to Silver Cards (Monthly). Hence it is decided to withdraw the sale of Gold Cards immediately.

# mon III. VALUE ADDITONS A HAW THE A RIM HOW MY ALLY MARK HARDE

The following value additions which were given through the circular No 29/2011-OPD(M) dated 20.06.2011 shall be continued forthwith.

- Permitting PVG Silver Card holder to travel in Express services with Combi ticket of Rs.5/- and Express Silver Card Holders to travel in Deluxe Buses with combi ticket of Rs.10/- on the specified routes.
- To allow Silver Card holders to travel in NON-STOP express buses also.

### IV. PERMITTING GOLD CARDS WHICH WERE ALREADY SOLD:

• The gold Cards which were already sold shall be allowed till the expiry of the validity period.

# V. PRINTING OF SILVER CARDS & TO OBSOLETE EXISTING STOCK OF GOLD CARDS:

- The existing stock of gold Cards shall be made obsolete as per the procedure in vogue.
  - A new condition 'Silver Card holder has to purchase "Toll Plaza User fee" Ticket when ever he travels and wherever applicable' shall be added to the existing conditions.
