Payment of commission on cancelled tickets:

Instructions issued through the Cir No 23/2011-OPD(MKTG) dated 18.05.2011 to pay proportionate commission on cancelled tickets, basing on the percentage of ticket amount retained by the Corporation, shall be continued.

All the Regional Managers shall conduct a meeting with the ATB agents and inform the increase in commission rates payable to ATB agents before implementation with an appeal to increase the sale of seats under BARAT.

The revised commission rates shall be implemented w.e.f. 05.01.2013.
