SUB: HIRING: Hiring of buses – revision of wage component in floor rate
– instructions issued – Reg

A provision has been made for all types of buses in the hire tender notifications to revise the base floor rate (increase/decrease) in line with the revisions in minimum wages. The prescribed periodicity to review cost component of wages in base floor rate is once in two years for hire buses of tender notifications issued from 2007 to 2010 and once every year for hire buses of tender notifications and replacements to earlier notifications issued from 2013 onwards.

The committee constituted by the competent authority to review cost component in floor rate towards wages of drivers has submitted its recommendations for payment of difference in increased wages over the existing wages. The competent authority with the concurrence of FA & CAO approved the recommendations of the committee and ordered for implementation.

Therefore instructions are hereby communicated to arrange for payment of difference in wage component in floor rate to hire buses introduced vide different notifications as shown at tables with reference to daily vehicle utilizations of respective buses as given below.

- Teluguvelugu type hire buses introduced in pursuance of 2010 Tender notification from the date of commencement of 9th year of agreement given at **Annexure-1**
- All types of hire buses introduced vide 2013 tender notification & express type buses introduced during 2013 as replacements to 2007 Tender notification from the date of commencement of 6th year of agreement given at **Annexure-2**

- Express, Teluguvelugu and City type buses which are introduced in pursuance of July & Dec 2014 tender notification from the date of commencement of 5th year of agreement given at **Annexure-3**
- All type of hire buses introduced vide 2015 December (except Indra) tender Notification from the date of commencement of 4th year given at **Annexure -4**
- Indra hire buses introduced vide 2015 December tender notification from the date of commencement of 4th year given at **Annexure-5**
- Express type hire buses which are introduced during 2015 as replacement to 2009 notification and Teluguvelugu buses introduced during the year 2016 to 2018 as replacement to 2007&2008 notifications from the date of commencement of 4th year of agreement given at **Annexure -6**

The prevailing hire rate payable per km to hire buses of said notifications/replacements from the date of commencement of said period is to be increased per km in paisa as indicated in the applicable tables enclosed subject to pre audit.


