CIRCULAR No. PD- 15 / 2018, Dated 17.07.2018.

Sub:-ALLOWANCES:- Continuation of HRA at the existing rate of 30% and CCA at the rate applicable in Hyderabad to the employees of APSRTC who migrated from Hyderabad to Vijayawada for a further period of one year w.e.f. 27.06.2018 on par with Government employees – Orders issued – Reg.

Consequent to the provisional bifurcation of APSRTC as 2 separate entities, the Corporate office of APSRTC was established in the RTC House in the NTR Administrative Block at Vijayawada and all the departments of APSRTC Corporate Office except Legal Cell, PF, and ISS, were shifted to RTC House, Vijayawada and commenced functioning w.e.f. 27.06.2016.

The House Rent Allowance (HRA) is being paid to the employees of APSRTC who are working in Greater Hyderabad and Secunderabad classified as A1 City at 30% of Basic Pay subject to a maximum of Rs.20,000/- p. m for employees and Rs.35000/-for Officers as per Circular No. PD-1/2015 dated 15.06.2015 and PD-03/2015 dated 10.07.2015 respectively. It was stipulated in the said circulars that the rates of HRA & CCA will be revised at the place and from the effective dates as and when the Government revises the same.

The Government of Andhra Pradesh have issued orders vide G.Os under reference 3rd and 4th cited to allow the HRA @ 30% and CCA applicable in the Hyderabad to the employees who migrate from Hyderabad to Vijayawada for a period of one year. The same facility was extended for a further period of one year vide G.O under reference 6th cited.


Based on the Orders of the Government of Andhra Pradesh, instructions were issued vide Cir.No.PD-30/2016 dated 18.06.2016, to allow HRA @ 30% subject to the maximum of Rs.20,000/- per month to the employees and Rs.35,000/- for Officers and CCA applicable in Hyderabad to the Officers / employees of units of the APSRTC shifted from Corporate Office, Bus Bhavan, Hyderabad to RTC House, PNBS, Vijayawada for a period of one year from the date of reporting at RTC House, Vijayawada on par with Government employees for a period of one year w.e.f 27.06.2016 vide reference 5th cited and the same is extended for further period of one year w.e.f 27.06.2017 vide circular under reference 7th cited.

Now, the Government of Andhra Pradesh have issued vide G.O.Ms.No.106 dated 06.07.2018 to continue the orders issued to allow 30% HRA and CCA applicable in Hyderabad for a further period up to 30.06.2019.

In terms of the orders of the Government of Andhra Pradesh issued vide reference 8th cited, the VC & MD with the concurrence of CAO has accorded approval to continue the HRA @ 30% of Basic pay, subject to maximum of Rs.20,000/- per month to Employees and Rs.35,000/- per month to Officers and City Compensatory Allowance at the rate applicable in Hyderabad to the Employees and Officers of APSRTC who migrated from Hyderabad to Vijayawada (working in Head Office Units) pending approval of the Board. The Employees who are directly transferred from different Units to RTC House, Vijayawada are not eligible for HRA @ 30% and CCA applicable in Hyderabad.

Necessary action shall, therefore, be taken accordingly.
