NOTIFICATION

Sub: SENIORITY- Publication of final Seniority list of Asst. Managers (P) working as on 31.03.2018 – Reg.

Through the notification 2nd cited, the provisional seniority list of 46 Assistant Managers (P) working as on 31.10.2015 in the residuary APSRTC on provisional allotment of state cadre employees consequent to bifurcation of APSRTC, was notified to the respective employees and to the offices concerned for information and confirmation. The said notification was subject to the final allotment of the state cadre employees as per the guide lines that were to be finalized at that time by the Corporation Board.

It was requested to send the objections received from the individual employees concerned on the seniority lists if any, besides any discrepancies noticed there in, after thorough verification of the data with that recorded in the P.Cases and other relevant files etc., along with proof on or before 20.11.2015. The objections and corrections so received were incorporated in the provisional seniority list cited above. However, the updated final seniority list could not be published for the reason that permanent allotment of state cadre employees between the two residuary entities was still pending at that time.

Sri K.R.C.Rao, E.505209, Sri P.V.Ramana, E.450639, Sri Y.V.Hari Kishore, E.206771 and Sri KV Prasad, E.455941, Sri M.I.Shafi, E.108061, RM/KRNL, AM's(P) had raised an objection to revise the order of seniority in terms of the Court Judgment in CA No.6631 to 6636/2015 dated 27.08.2015 and the same was replied suitably vide reference 2nd cited.

The common objection raised by the above AMs(P) is examined and appropriate replies were sent to the parties vide this office letter under reverence 4th cited.

The permanent allotment of state cadre employees was notified vide Notification No.PD-10/2017 dated 20.12.2017 under reference 3rd cited in accordance with the Board Resolution No.2/2017 dated 24.08.2017. All the state cadre employees who were notified to be allotted to TSRTC vide the above notification were relieved by 29.12.2017.

Since the work of permanent allotment of state cadre staff between the two residual entities is settled, the final seniority list of Assistant Managers (P) working in APSRTC has to be published duly incorporating the additions / deletions of personnel from 01.11.2015 to 31.03.2018 in the provisional seniority list cited above. The names of the Assistant Managers (P) given in Table I overleaf are deleted from the final seniority list of Assistant Managers (P) being notified now for the reasons mentioned against each.


