Payment of 40% of amount of arrears - Reg.

In terms of Memorandum of Settlement 1st cited, it was agreed by the Management and the APSRTC Employees' Union that certificates towards payment of arrears accrued on account of RPS, 2013 for the period of 24 months from 01.04.2013 to 31.03.2015 will be issued to all the in-service employees which are redeemable at the time of cessation of service without interest in view of the critical financial position of the Corporation. Accordingly, vide circular under reference 3rd cited, the statements of arrears were prepared, got audited and filed in the P cases of the employees besides issuing a copy of the certificate to the employees to that extent.

During the meeting held with the then recognized APSRTC NMU by the Hon'ble Transport Minister it was agreed to redeem RPS 2013 arrears for the in-service employees in 5 (five) equal instalments @ 20% each and to pay the 1st instalment on 10.06.2018. Accordingly instructions were issued vide reference 4th cited and 20% arrears amount was paid on 10.06.2018.

In terms of MoU signed between APSRTC Employees' Union and the Management vide reference 5th cited, it was agreed to pay the total balance amount of RPS,2013 in 2 instalments @ 40% each and to release the 1st instalment by 05.04.2019 and 2nd instalment by 30.09.2019.

Due to critical financial position of the Corporation, the payment of 1st instalment was delayed. Now, it is decided to pay the 1st instalment i.e., 40% of arrears on 23.05.2019.

The salary drawing officers concerned are therefore, advised to prepare the list of in-service eligible employees and release 40% of RPS, 2013 arrears on 23.05.2019 as the audited bills are already available. Necessary entries regarding the amount paid towards 2nd instalment and the remaining amount to be paid shall be made in the Personal Records and Service Registers of respective employees.
