Sub: DEARNESS ALLOWANCE: Payment of revised DA as applicable from 01.07.2019 to the employees of the Corporation in RPS 2017- Orders issued.

Ref: This Office Circulars No. PD-7/2019 dated 22.02.2019 and PD-9/2019 dated 22.02.2019

In terms of the instructions issued vide circulars cited above, the Dearness Allowance payable to the employees shall be revised twice in a year w.e.f. 1st January and 1st July based on the All India Consumer Price Index points for Industrial Workers published by Bureau of Economics and Statistic, Government of India.

Accordingly, the Dearness Allowance payable to the employees of the Corporation with effect from 01.07.2019 is worked to be 11.6% of the monthly pay. This revised DA at 11.6% w.e.f. 01.07.2019 of the monthly pay is to be implemented in place of DA that is currently being paid at 7.5% with effect from 01.01.2019.


The revised rate of Dearness Allowance shall be drawn in the regular salary bill for the month of August, 2019 payable on 01.09.2019 along with arrears for the month of July, 2019. This revised DA will be in force till the next revision is communicated.

- NOTE:1. "PAY" means basic pay fixed in RPS 2017 and changes that come about from time to time on account of increment/promotion/reversion/reduction in Pay etc., and shall include special pay and personal pay. It does not include Special Allowance.
2. The DA shall be calculated on basic pay of RPS 2017 and to be rounded off to the nearest rupee ie., less than 0.50 paise shall be ignored and 0.50 paise and above shall be rounded off to the next rupee.

The above rates of Dearness Allowance are not applicable to the Employees of other departments working on deputation in APSRTC.

Necessary action shall, therefore, be taken accordingly.
