Sub:-ALLOWANCES:- Continuation of HRA at the existing rate of 30% and CCA at the rate applicable in Hyderabad to the employees of APSRTC who migrated from Hyderabad to Vijayawada for a further period of one year w.e.f. 27.06.2019 on par with Government Employees - Orders issued - Reg.

Instructions were issued through circular 1<sup>st</sup> cited, to continue the HRA @ 30% of basic pay, subject to maximum of Rs.20,000/- per month to Employees and Rs.35,000/- per month to Officers and City Compensatory Allowance at the rate applicable in Hyderabad to the Employees and Officers of APSRTC who migrated from Hyderabad to Vijayawada(working in Head Office Units)pending approval of the Board.


It was also stipulated therein, that the Employees who are directly transferred from different Units to RTC House, Vijayawada are not eligible for HRA @30% and CCA applicable in Hyderabad.

Now, the Government of Andhra Pradesh have issued Orders through G.O.2<sup>nd</sup> cited, to continue to pay HRA @.30% of Basic Pay and CCA as applicable at Hyderabad to the Employees who were relocated / migrated from Hyderabad on shifting the Government of Offices i.e. A.P. Secretariat and Heads of the Departments to New Capital City of Amaravathi, Guntur and Vijayawada up to 30.06.2020.

In accordance with the G.O.MS.No.62, the VC&MD with the concurrence of FA&CAO has accorded approval to continue the HRA @ 30% of Basic Pay, subject to maximum of Rs.20,000/- per month to Employees and Rs.35,000/- per month to Officers and CCA @ applicable in Hyderabad, up to 30.06.2020, to the Employees and Officers of APSRTC who migrated from Hyderabad to Vijayawada (working in Head Office Units) pending approval of the Board.

The Employees who are directly transferred from Units other than those at Hyderabad, to RTC House, Vijayawada are not eligible for HRA @ 30% and CCA as applicable in Hyderabad.

Necessary action shall, therefore, be taken accordingly.
