SUB: UNIFORMS – Payment of Uniform Allowance in lieu of supply of Uniform Cloth to the eligible employees, supervisors and Officers of APSRTC for the years 2014- 15, 2015-16, 2016-17, and 2017-18 – instructions – Issued – Reg.


The Corporation is providing uniform to all the eligible employees @ 1 or 2 sets per year as applicable. Several complaints have been received from the union representatives that the cloth supplied by the Corporation is not found durable and colour shades are fading. It is also observed that uniform was not supplied to the employees from the year 2014-15 onwards. This issue was discussed during the meetings conducted on the representations of the Recognized APSRTC Employees union under Clause-3, with the Management and it is decided to pay the amount in lieu of uniform including stitching charges for the years 2014-15, 2015-16, 2016-17 and 2017-18 to eligible employees @ Rs.900/- per year per 2 sets and Rs.450/- per set as applicable to the male employees and @ Rs.1000/- to female employees.

The VC&MD with the concurrence of FA&CAO has approved the above proposal and to pay the Uniform Allowance to the eligible employees, Supervisors and Officers of the Corporation who are on rolls, towards the cost of Uniform and stitching charges for the preceding four years i.e. from 2014-15 to 2017-18.

Hence, all the Unit Officers concerned are therefore, instructed to arrange to keep the details of Uniform Allowance payable to the eligible employees, supervisors and Officers of the Corporation ready, as specified in the ANNEXURE – A duly pre-audited for the above period.

Payment shall be arranged in phases as communicated from the Head Office based on availability of funds.
