CIRCULAR No. PD - 2/2018, DATED: 06.03.2018

Sub: RPS-2013-ARREARS – Redemption of Arrears Certificates of RPS-2013 in five equal installments of 20% each—Payment of 1<sup>st</sup> installment of RPS-2013 arrears on 10.06.2018 – Orders - Issued – Reg.

In terms of Memorandum of Settlement 1<sup>st</sup> cited, it was agreed by the Management and the then recognized APSRTC Employees' Union and APSRTC National Mazdoor Union that certificates towards payment of arrears accrued on account of the Revision of Pay Scales – 2013 for the period of 24 months from 01.04.2013 to 31.03.2015 will be issued to all the in-service employees which are redeemable at the time of cessation of service without interest in view of the critical financial position the Corporation was facing at that time. Accordingly, in terms of instructions issued vide circular under reference 3<sup>rd</sup> cited, the statements of arrears were prepared, got audited and filed in the respective P cases of the employees besides issuing a copy of the certificate to the employees to that extent. As per the said agreement, the redemption of certificates has been implemented to all the employees at the time of cessation from service for various reasons so far.

During the meeting held with the recognized APSRTC NMU by the Hon'ble Minister for Transport on 05.03.2018, it was agreed to redeem the RPS-2013 Arrears Certificates for in service employees in five (5) equal installments at the rate of 20% of certified arrears each and to pay the first such installment of 20% on 10.06.2018 and the redemption of remaining 4 installments shall be scheduled in the first week of June in subsequent years depending upon the financial position. However, the redemption of certified amount in full as per eligibility will be continued to those employees at the time of cessation from service for various reasons.

The salary drawing Officers concerned are, therefore, advised to prepare the list of eligible employees to receive RPS-2013 1<sup>st</sup> installment of the arrears at the rate of 20% of such audited amount of arrears filed in the respective 'P' Cases, get it audited and pay the 1<sup>st</sup> installment of 20% to all the in-service employees on 10.06.2018. Necessary entries regarding the amount paid towards 1<sup>st</sup> installment and the remaining amount to be paid shall be made in the Personal Records and Service Registers of respective employees.

This has the concurrence of the FA and CAO.
