**CIRCULAR NO. PD - 07/2022, Dated: 18.05.2022**

Sub: **REORGANIZATION**- Reorganization of Zonal and Regional set up in APSRTC on the lines of GoAP- Restructuring of working jurisdictions of **Law Officers** (LOs) working in the Districts – Instructions – Reg.

1.0. The Organization structure of APSRTC was modified through the Circular at reference 1<sup>st</sup> read above by creating Zones which are headed by the Officers of the rank Executive Director controlling three Regions in each Zone, as shown below.

Zone	Regions
VZM Zone	NEC, VSP, EG
VJA Zone	WG, KRI, GNT
NLR Zone	PKSM, NLR, CTR
KDP Zone	KDP, KRNL, ATP

2.0. Vide G.O.s at 2<sup>nd</sup> read above, the Government of A.P. absorbed all the employees of APSRTC into Government service w.e.f.,01.01.2020 by creating a new Head of the Department by name Public Transport Department under the administrative control of T,R&B Department. As such, all rules applicable to the Government employees of other departments are as well applicable to PTD employees from 01.01.2020 onwards.

3.0. The Government vide G.O. at 3<sup>rd</sup> read above ordered for restructuring of 13 existing Districts into 26 districts in the state of A.P. It was further ordered to allocate the posts and personnel in the existing districts provisionally amongst the restructured districts, without affecting their inter-se seniority in any manner.

4.0. In terms of the approval communicated by the Government, vide G.O. at 4<sup>th</sup> read above, the existing 12 offices of Regional Managers have been restructured into 26 District Public Transport Offices, which shall function co-terminous with the new districts formed by the State of A.P.

5.0. Vide Circular at reference 5<sup>th</sup> read above, the erstwhile Zonal and Regional set up of APSRTC was modified and the revised Zonal and District level structure of AP PTD/APSRTC, on the lines of GoAP, was communicated.

6.0. Vide proceedings E4/255(01)/2022-PO-II, dated:13.04.2022, Officers were posted as DPTOs to head the 26 restructured districts in AP PTD/APSRTC. The Staff working in the erstwhile Regional Managers' office were issued "Order to serve to work in the restructured District Public Transport Offices in 26 districts.


7.0. In the erstwhile Regional and Zonal set up, total **5 LOs** (HO:2, Field:3) were working in the Districts. They have been looking after all the legal matters such as Labour courts, MACTs, Lok adalats, all types of Suits etc., pertaining to the districts attached to them.

8.0. In the backdrop of the revised Zonal and District set up in APPTD/APSRTC, it is now decided to allocate the **Law Officers** as given below.

9.0. LO:VSP shall provide legal assistance to the depots of EG, KKD and Konaseema Districts of Zone-2. LO:GNT shall provide legal assistance to the depots of WG, ELR, KRI and NTR Districts of Zone-2.

10.0. This has the approval of the competent authority. These instructions will come into force with immediate effect.
