Sub: ALLOWANCES - Payment of revised Dearness Allowance to the Officers and Employees of the Corporation with effect from 1st July, 2014 in RPS 2009 - Orders Issued.

The revision of Dearness Allowance is due to the Officers and Employees of the Corporation with effect from 1st July, 2014 in RPS, 2009.

Hence, it is decided to revise the rate of Dearness Allowance from 63.9% of Pay to 69.4% of Pay per month to all Officers and Employees of the Corporation with effect from 1st July, 2014, whose Pay has been fixed in RPS 2009.

The revised rate of Dearness Allowance shall be drawn and paid through the regular salary bill of October, 2014, after pre-audit.

- NOTE: 1. "PAY" means basic pay fixed in RPS 2009 and changes that come about from time to time on account of increment/ promotion/reversion/reduction in Pay etc., and shall include special pay and personal pay. It does not include Special Allowance.
 - 2. The D.A. shall be calculated on basic pay of RPS 2009 and to be rounded off to the nearest rupee i.e., less than 0.50 paise shall be ignored and 0.50 paise and above shall be rounded off to the next rupee.

The above rates of Dearness Allowance shall not be applicable to the Ex-TTD Employees, who have not opted to the service conditions of APSRTC and also to the Employees on deputation to APSRTC.

Instructions regarding payment of DA Arrears for the period from July, 2014 to September, 2014 will be issued later. However, in cases of retirements / deaths, the arrears shall be released in the settlements.

Necessary action shall, therefore, be taken accordingly.
