Sub: CONTRACTS – Revision of wages of Contract Labour – Payment of Minimum Wages to the Labour engaged by the Contractors – Reg.

Ref: 1) Circular No. PD-15/2014, Dated 20.05.2014.
2) Notification No.217, dated 20.05.2014 of Commissioner of Labour, Hyderabad published in the A.P. Gazette.

Instructions were issued vide Circular under reference 1st cited, prescribing the rates of wages payable to all the Contract Labour engaged in Maintenance Contracts, Sweeping and Washing of Buses, Maintenance of Garage yards and other Units, Maintenance of Bus Stations and other Contracts in the Corporation and the Contract Labour engaged in Maintenance of Toilets in Bus Stations, Depots and other Units.

The Commissioner of Labour through the Notification 2nd cited, published in the AP Gazette, has communicated the revised cost of living allowance payable to the Contract Labour engaged by the contractors, according to which all the contract labour and the Labour engaged in Maintenance of Toilets in Bus Stations, Depots and Other Units (Safai Karamcharis) in the Corporation are entitled to the following wages.

Accordingly, the revised wages shall have to be paid to the Contract Labour from 01.04.2014 onwards, as detailed hereunder .
