Sub: ALLOWANCES: Payment of revised Dearness Allowance to the Employees and Officers of the Corporation applicable from 1st Jan, 2017 in RPS 2013-Orders issued.

Ref: Meeting held with NMU on 03.05.2017.

The revision of Dearness Allowance is due to the Employees and Officers of the Corporation with effect from 1st Jan, 2017 as per RPS-2013.

Now, it is decided to revise the rate of Dearness Allowance from 28.5% of pay to 31.1% of Pay per month to all Employees and Officers of the Corporation with effect from 1st Jan, 2017 whose pay has been fixed in RPS 2013.

The revised rate of Dearness Allowance shall be drawn from the month of May, 2017 and paid through Regular Salary Bill of May, 2017.

NOTE:1. "PAY" means basic pay fixed in RPS 2013 and changes that come about from time to time on account of increment/promotion/reversion/reduction in Pay etc., and shall include special pay and personal pay. It does not include Special Allowance.

2. The DA shall be calculated on basic pay of RPS 2013 and to be rounded off to the nearest rupee i.e., less than 0.50 paise shall be ignored and 0.50 paise and above shall be rounded off to the next rupee.

The above rates of Dearness Allowance shall not be applicable to the Ex-TTD Employees, who have not opted to the service conditions of APSRTC and also to the Employees on deputation to APSRTC.

Instructions regarding payment of DA Arrears for the period from Jan, 2017 to April, 2017 will be issued later. However, in cases of retirements/deaths, the arrears shall be released in the settlements.

Necessary action shall, therefore, be taken accordingly.
