Sub: WELFARE – Grant of Educational Assistance to the Officers'/employees' children for prosecuting Professional Courses – Enhancement of budget – Instructions – Communicated – Reg

The welfare measure of providing Educational Assistance to the children of officers and staff who are pursuing professional courses, was introduced with an annual budget of Rs.10 lakhs vide Corporation Board resolution under reference 1st cited.

Later, the annual budget was enhanced from Rs.10 lakhs to Rs. 20 lakhs from the academic year 1999-2000 vide Circular under reference 2nd cited duly taking approval of the Board and subsequently, from Rs.20 lakhs to Rs.25 lakhs from the academic year 2002-03 as per the Circular under reference 3rd cited. Again the annual budget was enhanced from Rs.25 lakhs to Rs.50 lakhs vide Board Resolution under reference 4th cited from the academic year 2007-08.


In view of escalation in the fee of several educational institutions, the recognized APSRTC Employees' Union has represented for enhancement of the budget through its charter of demands submitted as a part of RPS-2013. During the negotiations, it was agreed to enhance the annual budget from Rs.50 lakhs to Rs.70 lakhs ie., an increase of 40%.

The existing budget amount of Rs.50.00 lakhs is common for undivided A.P.S.R.T.C. The Corporation was bifurcated into two separate entities as A.P.S.R.T.C. and RTC in Telangana Area w.e.f. 03.06.2015. Hence, the amount has to be distributed in 58:42 ratio to both States respectively. As such, the share of the existing budget of Rs.50 lakhs in the ratio of 58:42 (AP and TS) comes to Rs.29.00 lakhs towards the share of A.P.S.R.T.C. On enhancing the same by 40% as agreed in MoS dated 06.07.2015, the budget to be provided comes to Rs.40.60 lakhs which shall be rounded off to Rs.41.00 lakhs. It is proposed to implement the revised annual budget of Rs.41.00 lakhs from the Academic Year 2014-15.

In consideration of the representation of the recognized union and after negotiations, it has been decided to enhance the annual budget from the existing Rs.29 lakhs to Rs.41.00 lakhs towards educational assistance to the children of officers and staff pursuing professional courses from the academic year 2014-15 with the concurrence of FA&CAO pending ratification of the Corporation Board.
