- Sub: WELFARE – Enhancing the amount of funeral expenses to the legal heirs of retired employees and Officers of APSRTC – Revised Instructions – Issued - Reg.

In terms of Item No.13 of Memorandum of Settlement reached with the APSRTC Employees' Union (Recognized) on 06.07.2015, it was agreed to follow the government pattern or the existing scheme in APSRTC whichever is more beneficial to the in-service employees as well as retired employees in payment of funeral expenses.

At present, as a Welfare measure, vide reference 1st cited, an amount of Rs.5,000/- is being paid towards funeral expenses to the family members of Corporation employees who are expired after retirement including Officers.

The Government of Andhra Pradesh vide G.O.Ms.No.136, (Principal Secretary to Government(FP) dated 29.06.2011 issued orders enhancing the funeral expenses from the existing Rs.5,000/- to Rs.10,000/- to the legal heirs of the deceased Family Pensioner.

The Vice Chairman & Managing Director, with the concurrence of FA&CAO, pending approval of the Board, has accorded sanction to enhance the funeral expenses from the existing Rs.5,000/- to Rs.10,000/- to the legal heirs of Corporation employees and Officers who are expired after retirement.

The Unit Officers are therefore, advised to make payment of funeral expenses at enhanced rate to the legal heirs of Corporation employees and Officers who are expired after retirement with immediate effect.

The expenditure is chargeable to Account Head No. 6017.
