Sub: **CONTRACTS** – Revision of Minimum Wages payable to the Contract Labour and Security Personnel working on Contract basis (Out-sourcing) in APSRTC – Communicated – Reg.

Ref 1) Circular No. PD-24/2018 dated 09.08.2018.

2) Notification No.G.668 dated 01.10.2018 of Commissioner of Labour, Andhra Pradesh State published in the AP Gazette.

Instructions were issued vide Circular under reference 1<sup>st</sup> cited, prescribing the rates of wages payable to all the Contract Labour engaged in Maintenance Contracts, Sweeping and Washing of Buses, Maintenance of Garage yards and other Units, Maintenance of Bus Stations and other Contracts and the Security Personnel working in the Corporation on contract basis (Out-sourcing) and the Contract Labour engaged in Maintenance of Toilets in Bus Stations, Depots and other Units w.e.f. 01.04.2018.

The Commissioner of Labour, Andhra Pradesh through the Notification 2<sup>nd</sup> cited, published in the AP Gazette, has communicated the revised cost of living allowance payable to the Contract Labour, Safai Karmacharis and Security personnel engaged by the contractors. Accordingly all the Contract Labour and the Labour engaged in Maintenance of Toilets in Bus Stations, Depots and Other Units (Safai Karmacharis) and Security Personnel working on contract basis (Out-sourcing), falling in Andhra area, are entitled to the following revised wages w.e.f. 01.10.2018.

Accordingly, the revised wages shall have to be paid to the Contract Labour/ Security Personnel/Safai Karmacharis working on Contract basis (Out-sourcing) in the Depots/Units of APSRTC from 01.10.2018 onwards, as detailed hereunder.


