In terms of GOs at reference 1st to 3rd cited, all employees of APSRTC were absorbed into Government service w.e.f.01.01.2020 by creating a new Head of the Department by name Public Transport Department under the administrative control of Transport, Roads and Building department. Accordingly, salaries are being paid by the Government from the month of Jan,2020.

In terms of GO at reference 4th cited, age of Superannuation of all Govt. employees was enhanced to 62 years. As such, retirements commenced from Jan-2024 at all the units of APPTD.

Terminal benefits such as Gratuity, Terminal Leave Encashment and Additional Monetary Benefit payable to the employees in various types of cessations are given here-under.
