As per the existing item No.21 of Section - 14 of "Medical Matters' of Delegation of Powers, 2014, VC & MD with the concurrence of CAO, has powers to re-imburse expenditure upto Rs 1.00 Lakh incurred by Retired employee and spouse who opted to REMFS on emergency treatments like Heart ailment, accidents, Appendicitis subject to the condition that the information shall be given to the Unit Officer within 48 Hours and on production of documents within one month after discharge.

Of late, it is observed that the cost of treatment has gone up and many re-imbursement cases which require sanction for more than Rs.1.00 Lakh are to be processed for sanction of Corporation Board. As the Corporation Board meets once in two months, the cases which require Board approval are getting delayed and the retired employees are frequently approaching for reimbursement in view of their critical financial position in their old age.

On examining the issue, Board vide resolution cited, has accorded approval to enhance the sanctioning limit delegated to VC & MD towards reimbursement of the medical expenditure claimed by retired employees and or spouses up to maximum limit of Rs.4.00 Lakhs at a time under Retired Employees' Medical Facility Scheme – 2003.

It is hereby notified that as per revised Delegation of Powers, 2014 item No.21 of Section – 14 of "Medical Matters", V.C & MD with the concurrence of CAO, has powers to re-imburse expenditure upto Rs 4.00 Lakh incurred by Retired employee and spouse who opted to REMFS on emergency treatments like Heart ailment, accidents, Appendicitis subject to the condition that the information shall be given to the Unit Officer within 48 Hours and on production of documents within one month after discharge.

All the authorities concerned are requested to take note of the same and take necessary action accordingly.
