Sub: ALLOWANCES – Payment of certain yearly allowances to the AP PTD employees for the year 2024-25 – Notification – Issued - Reg.

Ref: G.O. Ms.No.114 (FINANCE (PC-TA) DEPARTMENT) dated 03.06.2022.

All the employees of APSRTC were absorbed into Government services w.e.f. 01.01.2020 by creating a new Head of the Department by the name Public Transport Department under the administrative control of T,R&B Department through G.Os.Ms.No.50,51 and 52 of T, R&B Department dated 31.12.2019.

Through the G.O.Ms.No.114 (FINANCE (PC-TA) DEPARTMENT) dated 03.06.2022, the Government have issued comprehensive guidelines regarding the payment of certain allowances to the AP PTD employees with effect from 01.06.2022.

The following yearly allowances are payable to the eligible employees in terms the G.O. Ms.No.114 (FINANCE (PC-TA) DEPARTMENT) dated 03.06.2022 which are applicable from 01.06.2022.

1. **Uniform Allowance** – (5.1 of G.O) –The uniform Allowance including stitching charges shall be paid as per Circular No.PD-23/2019 dated 28.08.2019 to all the eligible employees @ Rs.900/- per year per two sets and Rs.450/- per set in respect of the male employees and at Rs.1000/- to female employees.
2. **Foot wear Allowance** – (18.1 of G.O)- The Foot wear Allowance shall be paid at the rate of Rs.300/- per annum for the Mechanical staff working in NOU, Traffic staff in the cadres of ADC/Controller/DC/TI-III and Civil Engineering Department staff of the Public Transport Department.
3. **Shoe Allowance** – (19.1 of G.O) – The Shoe allowance shall be paid at the rate of Rs.360/- per annum for all Supervisors of Traffic, CED and Rs.450/- per annum for all Depot garage staff, all MED supervisors of Depots and NoUs of the Public Transport Department.

Hence, all the Unit Officers/DDOs are advised to take necessary action to draw the above mentioned yearly allowances for the year 2024-25 through CFMS as mentioned in the G.O.Ms.No.114 dated 03.06.2022 to the eligible employees, in the month of April 2024 along with due amounts for the previous years 2022-23 and 2023-24, if not already drawn.
