Sub: SBT(NEW) – SBT(NEW) scheme for the PTD employees of age 55 years and above, who are not covered under APGLIS of GoAP– Guidelines issued - Reg.

Vide notification at reference 1<sup>st</sup> read above, SBTF was dispensed with for the in-service employees w.e.f. 01.01.2020. It was further decided by the Government to settle the amounts to the in-service members' of SBTF with interest, within a reasonable time.

All regular PTD employees of below 55 years of age are covered under APGLI from November, 2020 onwards. The PTD employees of age 55 and above are not eligible for enrolment in APGLI Scheme, as per the rules of APGLI.

On consideration of the proposals submitted to the Government, vide Memo at reference 2<sup>nd</sup> cited, the Government have communicated no objection for continuation of the pre-existed SBTF to PTD employees who have crossed 55 years of age and not becoming eligible under APGLIS of GoAP.

Now, with the approval of the competent authority, it is decided to operate SBT(NEW) scheme to the PTD employees who have crossed 55 years of age as on 1<sup>st</sup> Dec, 2020 and not eligible for APGLIS of GoAP, with the following guidelines.

- 1) The SBT(NEW) Scheme shall come into force from 1<sup>st</sup> Dec, 2020 onwards to all PTD employees (who are on rolls as on 1<sup>st</sup> Dec, 2021) and who were not enrolled in APGLIS of GoAP.

- 2) Subscription @Rs.100/- per month shall be recovered from the eligible members of SBT(NEW) Scheme from the month of Nov, 2021 payable on 01.12.2021, onwards.
- 3) **Arrears:** Arrear Subscription for the period from Nov, 2020 (paid on 01.12.2020) to Oct, 2021 ( $100 \times 12 = 1200$ ) shall be recovered in 3 equal instalments @Rs.400/- per month from the salary bills of Nov, 2021, Dec, 2021 and Jan, 2022.
- 4) The benefits under this scheme (Death ex-gratia @ Rs.1,50,000/- and retirement ex-gratia) are applicable to the members of SBT(NEW) Scheme only who cease from service from 1<sup>st</sup> Dec, 2021 onwards.
- 5) All the general by laws as applicable to old SBTF are in principle applicable to the members of SBT(NEW) Scheme.
- 6) Secretary: SBT(NEW) shall manage the activities of SBT(NEW) scheme under the control of FA&CAO.

Therefore, all the unit officers are requested to notify the above contents to all the PTD employees concerned and take further necessary action.
