

The sanctioned posts of Officers in various cadres were reviewed and reduced from 421 to 410 and from 410 to 404 with the approval of the Corporation Board vide references 1<sup>st</sup> to 3<sup>rd</sup> cited above.

Consequent to the bifurcation of APSRTC into residuary APSRTC and TSRTC, the area of operation got significantly reduced to only 12 Regions organised in 4 Zones and spread across 13 districts of the State. In view of the reduction in the extent of geographical jurisdiction, the requirement of Police Officers to work in Vigilance & Security Department of residuary APSRTC on deputation basis, has been assessed and the Corporation Board, vide resolution 4<sup>th</sup> cited, in the meeting held on 10.09.2020 resolved:

- i) To revise the sanctions of Police Officers to be utilised in APSRTC on terms of deputation to "only one post" in the cadre of ASP of Police Department to work as Assistant Director(V&S) in APSRTC.
- ii) To attach the functions of DSP rank Officers of Police Department working as V&SOs on deputation in APSRTC to the Security Officers (earlier called V&SOs) of APSRTC(PTD)
- iii) To attach the functions of Circle Inspector rank officers of Police Department working as Vigilance Inspectors on deputation in APSRTC to the CSI rank supervisors of APSRTC (PTD)
- iv) To attach the functions of Director (Vigilance & Security) to the post of Executive Director (Administration), APSRTC who is of the rank of Additional Commissioner in the GoAP.

The above revised instructions will come into force with immediate effect.
