The Government issued G.O.Ms No.195 dated 12.12.2017 allowing to draw HRA @ 20% to the Government employees working at Srikakulam, Machilipatnam and Chittoor Towns ( Head Quarters of Srikakulam, Krishna and Chittoor Districts) with effect from 01.01.2018.

Accordingly, instructions were issued vide reference 3<sup>rd</sup> cited to allow HRA @ 20% to the employees of APSRTC working at Srikakulam, Machilipatnam and Chittoor towns (Head Quarters of Srikakulam, Krishna and Chittoor Districts) w.e.f 01.01.2018 and the same was implemented through the salary bill of March, 2018.

Now, the competent Authority has accorded sanction for payment of arrears of enhanced HRA to the employees working at Srikakulam, Machilipatnam and Chittoor Towns ( Head Quarters of Srikakulam, Krishna and Chittoor Districts) from Jan, 2018 and Feb, 2018 through the salary bill of June, 2018 payable on 01.07.2018.
