Instructions were issued vide Notification 3<sup>rd</sup> cited to recover monthly subscription Rs.5/- from the Supervisors & Officers and Rs.3/- from the employees through salary bill towards printing and circulation of Prastanam every month among all the employees.

Accordingly, the in house Magazine "APSRTC Prastanam" is being printed every month in a new format of 20 pages in dual colour i.e., black and white cover page on paper of news print quality from April, 2017 and is being circulated among all the employees of the Corporation duly incurring an expenditure of Rs. 1,32,922/- every month. It was suggested by the employees to print "APSRTC Prastanam" in multi colour while expressing utmost satisfaction about printing of the "APSRTC Prastanam". In order to get the cover page of RTC Prastanam printed in multi colour, the cost of printing increases from Rs.1,32,922/- to Rs.2,28,000/- .

In view of the above, it is now, proposed to print "APSRTC PRASTANAM" cover pages in multi colour i.e. 1<sup>st</sup>, 2<sup>nd</sup> and 19<sup>th</sup> & 20<sup>th</sup> page and to circulate among the Officers and Employees of APSRTC duly recovering Rs.10.00 from Officers and Supervisors and Rs.5.00 from the other employees in order to meet the increased cost.

The Competent Authority has accorded permission to recover monthly subscription @ Rs.10.00 from the salaries of Officers and Supervisors and Rs.5.00 from the salaries of other employees towards publication of "APSRTC PRASTANAM" monthly magazine in multi colour cover pages.

Therefore, All the Salary drawing authorities are requested to recover subscription every month @ Rs.10.00 from the salaries of Officers and Supervisors and Rs.5.00 from the salaries of other employees towards publication of "APSRTC PRASTANAM" monthly magazine commencing from the pay bill for the month of July, 2018 payable on 01.08.2018.
