Sub:-BUS PASSES – Sanction of travel concessions to retired Officers / Supervisors / Employees and allowing 50% concession to the Physically Challenged Persons travelling in Ultra Deluxe type buses – Revised instructions – Issued – Reg.

Through the circular 1st cited, VC & MD had accorded permission to extend the facility to the (i) Retired Officers, Supervisors, Employees and their spouses (ii) surviving spouses of expired employees (expired either while in service or after retirement) as follows.

- (a) to travel free of cost upto Deluxe services for both the retired employee and spouse.
and
- (b) to travel at 50% concession for both the employee and spouse in Super Luxury and above products.

Further, vide reference 2nd cited, detailed guidelines were also issued in allowing the employees on Inter-state services, issue of Identity Cards to the medically retired employees, spouses of the deceased employees, voluntarily retired employees and collection of fee for issuing Identity Cards to the eligible retired employees and spouses.

It is represented by the APSRTC Retired Employees' Welfare Association and other Unions to allow free travel facility in the newly launched Ultra Deluxe services also.

Further, the Regional Manager, Vijayawada vide letter 3rd cited sought clarification in allowing 50% concession to the Physically Challenged Persons travelling in the newly introduced Ultra Deluxe type Buses as a representation from the District Handicapped Welfare Association, Krishna District is received in this regard.

The representations have been examined and it is hereby decided to permit the free travel facility to the retired Officers, Supervisors, Employees & their spouses and surviving spouses of expired employees (expired either while in service or after retirement) in Ultra Deluxe type Buses also.

All the Unit Officers are advised to make a Stamp containing "Valid to Travel free of cost in Ultra Deluxe Buses also" and affix on the existing Cards given to the Retired Employees and surviving spouses till the newly printed cards incorporating the above change are supplied to the Units.

With regard to allowing concessional travel in Ultra Deluxe Buses to Physically Challenged Persons at 50% concession, instructions have already been issued vide letter 3rd cited to all Units Officers stating that differently abled persons, freedom fighters, journalists, Legislators & Ex.Legislators are eligible to travel in Ultra Deluxe Buses at 50% concession on the normal fare. Necessary software may please be installed in the TIMs incorporating the above changes in the concessional travel facilities provided to various sections of beneficiaries as given in this circular.

All the other instructions issued in the circulars 1st & 2nd cited with regard to travel concessions to the retired officers, supervisors, employees and spouses remain unaltered.

Therefore, all the Unit Officers shall take necessary action accordingly.
