Instructions were issued through Circulars 2nd & 3rd cited for payment of Conveyance Allowance to the Blind, Orthopedically Handicapped and Deaf & Dumb Employees of the Corporation @ 10% of Basic Pay subject to a maximum of Rs.650/- per month in addition to Residential Bus Pass. relative of APSETC Lauralla SangulAPSETC Linion Workers tinner &

Instructions were issued vide Circular 4th cited authorizing the Executive Director of Zones in respect of the employees working in Zonal Units and Executive Director(A) in respect of the employees working in Corporate Office, BBW, Printing Press and APSRTC Hospital, Tarnaka to sanction the Conveyance Allowance to the Blind, Orthopedically Handicapped and Deaf & Dumb Employees subject to the conditions stipulated in the circular 1st cited.

Subsequently, it was agreed that whenever the State Government revises the Conveyance Allowance to its employees who are Physically Handicapped, the same will be revised to the employees of the Corporation and as such, circular instructions were issued vide reference 6th cited duly revising the Conveyance Allowance from Rs.650/- to Rs.900/- per month since the Government of A.P. had issued G.O. vide reference 5th cited for payment of Conveyance Allowance to the Blind and Physically Handicapped Employees @ 10% of the Basic Pay subject to a maximum of Rs.900/per month.

Now, the Government of A.P., vide G.O.Ms.No.159, Dt.11.12.2015 under reference 7th cited ordered that the Conveyance Allowance shall be paid @ 10% of Basic Pay subject to a maximum of Rs.1,350/- per month to the Blind, Orthopedically Handicapped and Deaf & Dumb Employees.

Accordingly, VC&MD with the Concurrence of FA&CAO has accorded approval for enhancement of Conveyance Allowance from the existing 10% of Basic Pay subject to a maximum 900/- to that of 10% of Basic Pay subject to a maximum of Rs.1,350/- per month to the Blind, Orthopedically Handicapped and Deaf & Dumb Employees of the Corporation with immediate effect.

All the Unit Officers are, therefore, advised to take action for payment of Conveyance Allowance to the Blind, Orthopedically Handicapped and Deaf & Dumb Employees at the revised rates mentioned above. The other instructions issued earlier on the subject stand unaltered.
