OFFICE ORDER

Sub: ESTABLISHMENT – Promotion of Class-I Special Scale Officers to the rank of Class-I Super Scale as Executive Director on temporary basis under Regulation 30 – Orders – Communicated

It is hereby ordered that Sri R Sasidhar, CTM(Marketing&Commercial)&Director(Central Projects), Corporate Office in the cadre of Class – I Special Scale is promoted to the rank of Class-I Super Scale of Rs.130000-4000-158000 (RPS-2013) purely on temporary basis under Recruitment Regulation 30 of APSRTC Employees' (Recruitment) Regulations, 1966. His promotion is subject to the guide lines on allocation of state cadre officers to be finalized by the Corporation Board.

On promotion, he is posted as Executive Director (Marketing&Commercial):Corporate Office, RTC House, Vijayawada in a newly created post. He shall look after the functions of Marketing and Commercial activities. Consequently, the Executive Director (O, M&C) & Projects is relieved of the functions now entrusted to the Executive Director (Marketing&Commercial) and as such is redesignated as Executive Director (Operations&Projects).

Sri R Sasidhar should effect the promotion in terms of Regulation 4(d) and (e) of the APSRTC Employees' (Service) Regulations, 1964.

His pay on promotion will be regulated by the pay and allowance regulations and circular instructions issued on Career Advancement Scheme.

His temporary promotion is subject to the guidelines on final allocation of officers between two states, rescheduling of roster as per the guidelines to be received from the Government of AP consequent to bifurcation of the state, ratification by the Corporation Board and approval from the Government.

Orders posting substitute on the post of CTM (Marketing&Commercial)&Director(Central Projects) are issued separately.
