The Government of Andhra Pradesh through the G.O.Ms.No.36, dt.05.09.2001 vide reference 1<sup>st</sup> cited, issued instructions to dispense with Compassionate Appointments in the State Level Public Enterprises and in lieu thereof Ex-gratia be paid.

Based on the G.O. issued by the Government, instructions were issued through Notification No.17/2002, dt.16.09.02 vide reference 2<sup>nd</sup> cited, not to register fresh applications from the dependents of the deceased employees to any posts as there are no possibilities for providing employment under Bread Winner Scheme. However, on representation made by the then Recognised Union, instructions were issued again to register applications under Bread Winner Scheme for the post of Driver Gr.II and Conductor Gr.II only vide Lr.No.GC2/439/2002-PO.I. dt.17.05.2003.

Comprehensive Instructions were reiterated with regard to recruitment of dependents of employees died in harness under Bread Winner Scheme vide Cir.No.PD-30/2000 dt.05.05.2000.

On repeated requests made to the Government to restore the Compassionate Appointments in the Corporation to consider the cases of all eligible applicants who are registered under the scheme of Compassionate Appointment from 01.01.98 onwards, the Government through G.O.Ms.No.2. dt.05.01.13 vide reference 3<sup>rd</sup> cited. accorded permission to VC & MD. APSRTC, to provide Compassionate Appointments to all the eligible dependants of the employees who died in harness, numbering around 1120 pending since very long time w.e.f. 01.01.1998 in A.P.S.R.T.C. against the sanctioned vacancies as per the Recruitment guidelines in vogue subject to fulfilling eligibility criteria and qualifications, with retrospective effect, as a special case and as one time measure.

In view of the G.O. issued by the Government to consider Compassionate Appointment to all the eligible dependents of the employees who died in harness numbering to 1120, all the Regional Managers are advised to commence the Recruitment Process for the posts of Drivers, Conductors and Shramiks as per the comprehensive Circular instructions issued from time to time from Corporate Office on the subject.

The number of applications registered under Bread Winner Scheme as consolidated from the Bread Winner Scheme Periodical is enclosed according to which the Government has given permission to re-implement Bread Winner Scheme duly limiting the number to 1120 as on 31-12-2010.

Hence, all the Recruiting Authorities are requested to go ahead with the recruitment process to the categories of Drivers Gr.II. Conductors Gr.II and Shramiks limiting the number as indicated in the enclosure and subject to the eligibility criteria as specified from time to time, and only on ensuring that Additional Monetary Benefit is not paid to candidates under consideration.
