per the existing qualifications prescribed for the post of Grade.III communicated vide notification 3rd cited, the candidate must have been holding a Driving Licence valid for HPMV and HGV continuously for a period of not less than 3 years on the date of selection.

The Transport Commissioner vide Circular Memo 2nd cited has rationalised the existing categories of vehicles for the purpose of obtaining driving licence. With the result the categories viz., Medium Goods Vehicle, Medium Passenger Vehicle, Heavy Vehicle and Heavy Passenger Vehicle has been amalgomated into category viz., "TRANSPORT". Henceforth the endorsement will be authorised to drive Heavy Transport Vehicle. This amendment is into effect from 14.11.1994. As such the licence holder of Heavy Transport Vehicle" endorsement is entitled to drive Heavy Goods as well as Heavy Passenger Vehicle.

In view of the Circular Memo issued by the Transport Commissioner the following clarification is issued:

- The candidates with the endorsement of authorisation to drive the "Transport" vehicle should be also considered since the Licence Holder with "Heavy Transport Vehicle" endorsement is entitled to drive HGV and HPV vehicles. In other words, the candidates should be in possession of either "Transport" vehicle endorsement or Heavy Goods Vehicle/Heavy Passenger Vehicle endorsement.
- i) The candidates should have a Badge to drive public service vehicle as required under Rule 37 of A.P.M.V. Rules.
  - ii) It is further clarified that the maximum age limit prescribed is 45 years for the persons who are former members of the Defence Service of India (Refer to Circular No.PD-7/92-HRD, dated 19 February, 1992).

The Circular 3rd cited is deemed to have been amended to the above effect and the other terms and conditions remaining the same.
