Sub: RECRUITMENT REGULATIONS - Amendment to the Recruitment Regulations prescribed for the post of Driver Gr.II - Relaxation of Height and Heavy Vehicle Driving Experience- Notified - Regarding.

2. Govt's approval Lr.No. 423/Tr.II(2)/2010-1, dt.08.02.2010.

The Corporation Board through the Resolution No. 115/09, dt. 09.12.2009, has approved the amendment to Recruitment Regulations for the post of Driver Gr.II, duly reducing the minimum height of Drivers from 165 cms to 160 cms, Heavy Vehicle Driving experience from 5 years to 18 months and Heavy Vehicle Driving Experience under Training Scheme from 2 years to 1 year, for all categories of candidates and all types of Recruitments i.e., General and Limited as detailed below.

The Government have conveyed approval for the amendment as shown above vide their letter 2<sup>nd</sup> cited with certain conditions specified here under.

The drivers who possess the required driving skills as tested by the Committee only are to be considered and to be filled in communal rosters. The training would be imparted to the selected drivers for a period of one month at Zonal Staff Training colleges and after completion of training, their driving skill are again assessed by another Committee and the Drivers who pass the test only are chosen to be inducted in to the Organization, so as to ensure the safety of the commuters.

The amendments are deemed to have come into force with effect from 8.02.2010. Hence Recruitment Regulations for Driver Gr.II post are amended to the extent of above only and other conditions remained unaltered.

The training would be restricted to the selected driver for a period of one month at Central Staff Training College and after completion of training their driving skill are again assessed by another Committee and the Drivers who pass the test only are chosen to be included in to the Corporation, as to ensure the safety of the commuters.

The amendments are deemed to have come into force with effect from 01.02.2010. Former Recruitment Regulations for Driver Gr.II post are amended to the extent of above only and other conditions remained unaltered.
