Instructions were issued through notification cited under reference 3rd clarifying that the 4% reservation to BC-E shall not be notified in the Employment notification in view of the Hon'ble High court orders in W.P.No.15267 of 2007, dt. 8.2.2010.

Challenging the decision of the full bench of the Hon'ble High court of A.P., the Government of AP has filed Special Leave Petition before Hon'ble Supreme Court.

Vide ref. 4th cited, the Hon'ble Supreme Court has directed that the act passed by the A.P. Legislature giving 4% reservation to group 'E' of the backward classes was challenged before the High Court and the same was struck down by the High Court on various counts. As several constitutional issues are involved in these appeals, as an interim measure, we direct that for the time being, reservation of 4% be extended first to the 14 categories mentioned in the schedule appended to the Act (The Andhra Pradesh Reservation in favour of socially and educationally Backward classes of Muslims Act, 2007) (Act No.26 of 2007), excluding Creamy Layer. This is a temporary measure till the matter is finally decided

In view of the Hon'ble Supreme Court orders, it is decided to implement BC-E reservation for Muslims falling under first 14 categories mentioned in the Circular No. 45/2008, dt. 6.10.2008, which is also listed at the back side for ready reference. The instructions given vide notification no. 3/2010, dt. 18.03.2010 are with drawn, w.e.f 26.03.2010...
