Sub: TESTS - Departmental qualifying test for promotion to the post of Junior Clerk - Criteria adopting in Selection of candidates and for fixing their seniority in the post of Junior Clerk - Instructions-Issued.

Instructions were issued communicating the mode of selection for the post of Junior Clerk to be filled in by direct recruitment as well as by promotion in the circulars cited above. Marks have been allotted to different criteria for selection to the post of Junior Clerk both by direct recruitment and by promotion. The recognised union has represented that for the purpose of promotion to the post of Junior Clerks instead of competitive merit, only those who have qualified in the test may be considered based on seniority. The matter has been examined and it is decided to fix the qualifying marks as 50% for consideration of employees in the cadres of Conductors, Routine Clerks, Telephone Operators, Comptists etc for the posts of Junior Clerks.

The allotment of marks as communicated in the circular 1 cited shall hold good. However, the panel of selected candidates shall be prepared based on the cadre seniority from among the candidates who secured 50% of marks in the total marks prescribed for different criteria including interview. The other conditions stipulated in the circular 2 cited shall remain unchanged.

These instructions shall come into force with immediate effect.
