Guidelines were issued through Circulars cited, the time limit for submission of Appeals and Review petitions for Direct Recruits for various posts at the time of initial Medical examination and during the periodical Medical examination.

Directives were sought by some of the Regional Managers in regard to the time limit for submission of Appeals and Review petitions by Medically unfit Drivers/Conductors who are selected for engagement on contract basis .

In order to extend the same provision as applicable to the Regular employees, the Medically unfit Driver/Conductor candidates who are selected for engagement on contract basis shall also be allowed to submit Appeals and Review petitions as indicated below.

1. APPEAL :- To be submitted within Six weeks from the date of initial/periodical medical examination to the Appellate Authority.
2. REVIEW PETITION: To be submitted within twelve weeks from the date of decision of the Appellate Authority to appear before the Medical Board.

These instructions shall come into force with immediate effect.
