MEMORANDUM

Sub: SERVICE REGULATIONS - Implementation of Rule of Reservation in respect of Scheduled Caste candidates - Clarification on ABCD classification in view of Judgement dated 5.11.2004 of Hon'ble Supreme Court - Issued.

Instructions were issued through the circular 1st cited for implementation of the ABCD classification of Scheduled Casts in every roster of 100 points for direct recruitment.

Based on the guidelines issued by the Govt. through the G.O.Ms.No.2 dated.9.1.2004, comprehensive instructions were issued through circular No.PD-26/2004 dt.28.6.2004 for implementation of Rule of Reservation in promotions in favour of SC/ST employees. The same roster points as in the case of Direct Recruitment have to be implemented in respect of promotions also.

In view of recent judgment of Hon'ble Supreme Court on the subject, certain units have sought clarification whether to implement ABCD classifications in Scheduled Castes while implementing Rule of Reservation in promotions.

In the wake of Judgement of Hon'ble Supreme Court, the Government, through the G.O 3rd cited, have cancelled the Andhra Pradesh Scheduled Castes (Rationalisation of Reservations) Rules 2000 issued through the G.O Ms.No.47 S.W(CV1) Department, dated 31.5.2000.

Therefore, the issue has been examined with reference to the orders issued by the Government.

P.T.O

It is hereby ordered that all the Unit Officers should consider the candidates belonging to Scheduled Castes on the basis of their seniority without applying ABC Classification while implementing the Rule of Reservation in promotions/Direct Recruitment.


Necessary action shall be taken accordingly.
