Subject:- <u>DISPOSALS</u> – Disposal of Un-Serviceable Vehicles / Materials/ Tyres etc., through Periodical Tender-Cum-Auctions / Limited Tenders – Revised Guidelines – Regarding.

As per the directive of Vice-Chairman & Managing Director, the existing Auction Procedures laid down in SPD Manual (Section-G), Terms and Conditions of the Tender-Cum-Auction, all the relevant Circulars in force and Delegation of Powers – Section-6 of 2005, are studied by a Committee consisting of CFM/ CCOS / Dy.CAO (B&F) / COS© -I. The Committee had recommended to incorporate certain changes in the present system. The recommendations submitted by the Committee are approved by the Vice-Chairman & Managing Director with the concurrence of FA/CAO. Accordingly, Existing procedures shall get revised for effective functioning of the disposal activity. In this regard the following are the revised instructions/guidelines in respect of Disposal of Un-Serviceable Vehicles/Materials/ Tyres etc., through Periodical Tender-Cum-Auction / Limited Tenders to be followed with immediate effect (In respect of items for which no revised procedure/guidelines are given, the existing procedure/guidelines stand good).

ISSUE OF SALE ORDERS OF ED(Z) & MD APPROVED LOTS

Item 3(d), (e) of release procedures of Disposal section Section-G of SPD manual-Page-182-d

- a) Choice shall be left to the dealer a) No change to take separate Sale Orders for ED(Z) approved lots or wait till approval of MD is also received and take a single consolidate sale order.
- b) While indicating the due dates for payment, the practical feasibility of releasing the lots, on those dates shall be kept in view.

II **CLASSIFACTION OF ITEMS**

Item 9 of Classification of U/S Lots of Disposal Section-G of SPD manual page 171 classification of A,'B',&'C' class items is done based on the value of individual lots as under:

A'Class Items: Lot Value more than Rs.10,000/-

B'Class Items: Lot Value between Rs.1,000/- and Rs.10,000/-

'C' Class items:Lot value less than Rs.1000/-

'A' Class items: Lot value more than Rs.50,000/-

'B' Class items: Lot Value between Rs.5,000/- and Rs.50,000/-

'C'Class items: Lot value less than Rs.5,000/-.

III DELEGATION OF POWERS : ED(ZONE)

As per DoP 2005, item 27 of Section 6"Purchase and disposal of Stores" ED(Zone) is delegated with the following powers

- a) Powers to approve the disposal of 'A'
 Class material/vehicle / equipment
 lots when the rates obtained or equal
 to or more than previous three
 approved auction rates and upset
 values (wherever fixed)
- b) Full powers in respected of 'B' & 'C' Class material lots.
- a) Powers to approve the disposal of A'-Class material /vehicle / equipment lots when the rates obtained are equal to or more than previous two approved actions rates and upset values (wherever fixed)
- b) No change.

IV VALIDITY OF TENDER

Item(2) of Terms & Conditions for sale-RTC-257 "The offer should be valid for three months from the date of Tender cum auction."

"The offer should be valid for <u>50</u> days from the date of Tender cum Auction"

V <u>LIFTING OF MATERIALS AFTER</u> PAYMENT.

Item 9 of Terms & Conditions for sale-RTC-257

- a) After obtaining the Money Receipt for full payment a period of 7 working days from the date of payment will be given for lifting at the purchaser's risk
- a) After obtaining the Money Receipt for full payment a period of 15 working days from the date of payment will be given for lifting at the purchaser's risk.

b) Cir.No.PO©/I/Dis/Penalties(DD)/2001-2002/SPD,dated.09-11-2001 - Zonal COSs/Dy.CAOs were asked to advise the successful highest tenderers to obtain the Demand Drafts payable on the respective State Bank of India and State Bank of Hyderabad with which the Zonal stores is having account, to fecilitate faster realization of Demand Drafts.

Sl.No.21 of Disposal Section Manual of SPD page 176 Negotiations are being made as per the following manual instructions "If the Corporation is going to derive substantial benefit by entering into negotiations, the competent authority at Head Office may authorize negotiations."

Considering the revised validity time/delay involved in the negotiation process and for quick disposal, recommendations shall be given either to accept or reject the highest offer, without proposing any negotiations.

VII EMD (EARNEST MONEY DEPOSIT) Item 4 of Terms & Conditions for sale RTC-257

a)All the offers should be accompanied by Earnest Money Deposit (EMD) @ 5% of the total value offered for the LOTs.

a)All the Tender offers should be accompanied by Earnest Money Deposit(EMD)@, 10% of the total value offered for the LOTs.

b)After opening of the tenders, the highest Bidder or Tenderer will have to pay an addional 5% EMD
