With reference to your letter cited at reference 23, it is to inform you that in the G.O.Ms.No.30 dt.09.08.2012 it is clearly mentioned that you are entitled for service charges of 1.75% for the e-auction of scrap and there is no pre condition that the entire work of e-auction should be entrusted to you and also there is no pre condition that the Reverse E-auction is also to be carried out simultaneously.

Hence, as APSRTC is also Government Organization, as you cannot discriminate between the Government Departments, you are requested to confirm the service charges @ 1.75% only, so as to take the necessary action.

- 2. As already informed vide this office letter cited at ref.21st, for the Offers received through e-Auction, the offer should be valid for 50 days from the date of auction as against 30 days mentioned by you in your letter cited at ref.24th. You are, requested to arrange for incorporation of this change and confirm the same for further action.
- 3. Further, vide letter 25th cited, SO(D&T)HZ/UPL informed that in the recent e-auction concluded at HZ/UPL, the validity of the Demand Drafts obtained in the form of EMD in favour of Dy.Chief Accounts Officer and received at the end of M/s MSTC is expired by the time they are forwarded to Dy.CAO(HZ)/UPL.

As the DD's for payment of EMD are being received at the office of M/s MSTC, it is your responsibility to ensure that the DD's obtained are transmitted to the respective Dy.CAO(Zone) well before the validity period of the DD's submitted for EMD and it is also your responsibility to ensure the extension of the period or obtaining a fresh DD till such time they are forwarded to the Dy.CAO of the Zone concerned.

It is requested to take immediate necessary action in this regard and confirm the measures taken.
