CORRIGENDUM TO CIRCULAR NO. PD-10/99, DT. 28.01.1999

Sub: RECRUITMENT - Recruitment to the post of Drivers - Revised method of selection - Reg.

Ref: Circular No. PD-10/99, Dt. 28.1.1999.

During the meeting of EDs/RMs/HODs held with VC & MD on 5-4-1999 the contents of Circular No. PD-10/99, dated 28.1.1999 pertaining to revised method of selection for the post of Driver were discussed in detail. Executive Director, Karimnagar and some other Officers were of the opinion that by calling the candidates in the ratio of 1:4 in each category of SC, ST, BC-A, BC-B, BC-C, BC-D, OC etc., based on Driving Licence seniority, there is a possibility that the best available Drivers with good driving ability and relatively junior in driving licence seniority may not get selected and hence the Corporation may not be able to get the best driving talent available in the market.

The above subject was further discussed in VC & MD's chamber on 5-4-1999 during which time ED (A), ED (KRMP), CM (HRD) and Dy. CPM (Rectt.) were present. The consensus opinion that emerged during the meeting was that the above Circular may be suitably modified to the effect that all eligible candidates be called for driving test, so that candidates possessing the best driving talent can be selected.

In pursuance to the above discussions and consensus opinion that emerged during the meeting, the Circular No. PD-10/99, dated 28.1.1999 is modified to the extent indicated below:

- i) The sub-para in the para 2.4 in the Circular cited - starting with the sentence "From among the eligible candidates in any of the above four categories as minimum required" is deleted.
- ii) The para 2.5 starting with the sentence "Candidates should be called for Driving Test in the ratio of 1 : 4 as per seniority prepared at para 2.2 above" is also deleted.
- iii) Para No. 2.6 is renumbered as para No. 2.5.

After scrutiny of the applications by the screening committee, all the eligible candidates who are in possession of the requisite qualifications prescribed for the post of Driver shall be called for Driving Test.


The Circular No. PD-10/99, Dt. 28.1.1999 is modified to the extent indicated above. The remaining contents of the Circular stand good.
