For the purpose of determining the rate of stipend payable to ITI apprentices, the period of training already undergone by them in school or other Institution recognized by the National Counsel shall be taken into account.

All the Unit officers are advised to pay the stipend to Graduate Apprentice (Engineering Graduate), Technician Apprentice(Diploma Holders) in Engineering (for post institutional training) and Technician (Vocational) Apprentices (+2 Vocational Certificates holders) at the enhanced rates indicated above w.e.f. 23rd December 2014 and for ITI Apprentices of Ist, IInd and IIIrd year at the enhanced rates indicated above w.e.f. 22nd September, 2014.
