The Corporation has been inducting ITI Apprentices into the Corporation every year which is statutory on part of the Corporation.

Applications are being called. The candidates who apply for the post are called for certificate screening. Those whose records are found to be in order are issued with Hall Tickets to appear for a written examination.

The selection among other things is based on the performance in the written exam, marks obtained in ITI etc communicated vide VC&MD Lr.No.T2/21(22)/93-HRD, dt.24.08.1994 and Lr.No.T2/20(6)/2000-TRG, dt.30.06.2000. The apportionment of marks for various items of selection being followed at present is indicated below:-

The present practice of selection though written examination is very lengthy and fraught with lot of difficulties. It is time taking and a lot of administrative effort is required to ensure that the exam is conducted in a smooth manner.

In the circumstances explained, it is proposed to do away with the written examination.

The composition of Selection Committee is also revised.

The following revised instructions are issued for selection of ITI Apprentices in the Corporation:-

1. Apportionment of marks: The marks meant for written exam will be clubbed in ITI marks raising the ITI weightage marks to 70. The detailed apportionment of existing and revised marks is indicated below:-

Further, all the Principals shall take necessary action to conduct ITI Apprentices selections as per schedule.
