## OFFICE ORDER

Sub: TRAINING - Training to the APSRTC Constables selected under Bread Winner Scheme for a period of 4 months - Orders communicated - Reg.

Ref: 1. This Office Lr.No.even dated.29.03.2016 of VC&MD, APSRTC,  
2. Lr.No.Rc.No.212/Trg./2016, dt.22.04.2016 of Chairman SLPRB & IGP, Training, AP.

The VC&MD has accorded sanction to conduct training to the newly recruited 293 RTC constables (239 male and 54 female) under Bread Winner Scheme for 4 months, out of which 9 weeks training will be executed at Police Training College (PTC) and for remaining 7 weeks under respective ZSTCs. The number of candidates may decrease/increase due to medical unfit/new induction etc.

The following instructions are issued in this regard:-

**1. Training Period :**

The training shall be for a period of 4 months as communicated vide reference (1) cited. Out of the 4 months, 9 weeks training will be imparted at the Police Training Colleges (PTC) of Ongole and Vizianagaram. The list of candidates to be trained in PTCs is attached to this office order for the information of the Principals of PTCs and Principals of ZSTCs.

After completion of the training at PTC the Principals of Nellore & Vizianagaram shall take necessary action to direct the candidates to respective ZSTCs for imparting remaining 7 weeks training at ZSTCs.

**2. PTC Training Fee:**

An amount of Rs.7000/- per month is payable per candidate to the PTC towards training charges, food, refreshments and accommodation for the first 2 months. The Principals of ZSTCs shall arrange payment to the Principals of PTCs depending upon the number of candidates attending to the training programme.

For the last week (i.e. 9<sup>th</sup> week) of the training programme at PTC the amount shall be paid to PTC on pro-rata basis. 50% of the amount shall be paid to the Principals of respective PTCs by the Principals of ZSTCs before commencement of the training programme. Balance 50% shall be paid during the last week of the training programme.

The modalities for payment shall be worked out by the Principals of ZSTCs of Nellore & Vizianagaram in consultation with Principals of PTCs.

**3. Stipend payable during the training period:**

An amount of Rs.9000/- shall be drawn and paid every month to the Trainees as stipend. The Principals of ZSTCs Nellore and Vizianagaram have to make necessary arrangements for payment of stipend to the trainees on 1<sup>st</sup> of the month.

**4. Tariff for Food & Accommodation:**

An amount of Rs.3,500/- per month shall be recovered from the candidate towards cost of providing food & accommodation to them. This amount shall be recovered from the stipend payable to the candidates and the balance amount should be paid as stipend.

**5. Supply of Uniform etc:**

The trainees shall attend to the training in full Uniform and Shoes. The Stores Department at Head Office has been requested to supply the Uniform to the trainees. They are taking necessary action to procure Uniform and certain other miscellaneous items to the trainees. The Principals of ZSTCs Nellore & Vizianagaram shall arrange to collect the same from the Stores Department of Head Office and supply the same to all the trainees. Letter addressed to CCOS is enclosed to this letter for information of Principals of ZSTCs.

**6. Faculty for In House subjects:**

The PTCs will impart training both in theory and practice. Wherever inputs have to be provided pertaining to APSRTC they will make a request on the Principals or local Officers to depute our Officers as faculty members. In such cases the faculty fee shall be borne by APSRTC and the Principals of ZSTCs of Nellore & Vizianagaram shall make arrangements for payment of faculty fee as per the Circular instructions in vogue.

**7. Coordinators:**

The Principals of ZSTCs of Nellore & Vizianagaram are nominated to act as Coordinators while the candidates are undergoing training at PTCs. It shall be responsibility of the both the Principals to coordinate and be in continuous touch with the Principals of PTCs and ensure that the training programme at PTC progresses smoothly.

After successful completion of training at PTC as well as ZSTCs the candidates shall be directed to V&SOs for further posting orders.

The Principals of ZSTCs of Nellore and Vizianagaram are advised to take note of the above instructions and act accordingly and ensure that the training programme is carried out smoothly.
