Automated Driver Testing Tracks (ADTT) have been established at ZSTC/VJA and ZSTC/KRNL with the primary aim of testing the driving skills of Heavy drivers. The ADTTs are fully operational.

The Transport Department authorities have approached us and requested for utilization of the track by them to test the Drivers for the purpose of awarding Heavy Driving Licence.

The Principal ZSTC, Kurnool has also informed that utilization of track by Transport Department on payment basis can fetch income to the Corporation by testing Drivers on the track for issue of license by RTO on payment basis. Besides it will help in effective utilization of Automated Driving Test Track and requested for directive in the matter.

The matter is examined in detail and it is decided to permit the Road Transport Authorities to use our ADTT to test candidates for award of Heavy Licences on payment basis.

The fee to be collected along with Terms & Conditions is given below:-

## II. Terms and Conditions:

- a. The Transport Department should intimate their request to conduct tests to the Drivers on our Track at least one week in advance.
- b. For any damage of track, property and machinery the cost should be made good by the Transport Department to the extent assessed by the Corporation.
- c. Cost of stationery should be borne by Transport Department.
- d. All the manpower required relating to operation of A.D.T.T. shall be provided by Transport Department except system in-charge who will be provided by APSRTC.
- e. Vehicle for testing of Drivers shall be provided by Transport Department along with related expenditure like diesel, spares etc.
- f. Any additional accessories equipment should be borne by Transport Department.
- g. A programme coordinator should be deputed by the Transport Department to avoid clash of dates with the driving tests of Zonal Staff Training College.
- h. The security aspects, discipline of the drivers all these aspects should be taken care by the Transport Department.
- i. Any claim should be cleared by the Transport Department within 15 days.

The Principals of ZSTC's are advised to take note of the fee structure and Terms & Conditions and permit the Transport Department authorities to conduct Driving test on our ADTT for grant of Heavy Licence.
