Sub: **TRAINING**:- Enhancement of rate of honorarium to internal and external faculty members invited to Transport Academy and ZSTCs - Sanction communicated Reg.

The Board, through its Resolution 1st cited, has authorized the VC&MD to fix honorarium to the faculty as the circumstances demand from time to time, with the concurrence of CAO. The last revision of faculty fee was done in the year 2009 through Circular at ref. (3) cited. Based on a proposal from this office, the VC&MD, with the concurrence of the FA&CAO, has accorded approval to enhance the rates of honorarium to internal and external faculty members invited to deliver lectures at Transport Academy/ZSTCs at the rates enumerated below:

Note: Honorarium is not payable to Officers, Supervisors, and Staff on the rolls of Transport Academy/ZSTCs.

The VC&MD further, ordered that for special training programmes, wherein eminent faculty are called for, including free lancers from within the state or from out of the state, the ED(A&P)&(H&M) is the Competent Authority to decide the amount to be paid towards faculty fee.

The enhanced rates will come into force w.e.f. 01.07.2016. The Principals are advised to take note of the same and act accordingly. Further, the principals shall constantly endeavour to ensure that quality lectures are delivered at our training institutes.
