Sub: **APPRENTICES** – Engagement of ITI Apprentices in the Corporation - Conduct of Practical examination to the ITI Apprentices under All India Trade Test (AITT) - Communication of practical examination syllabus for the various ITI Trades and related instructions thereof - Reg.

Ref: 1.Director(TTC), Controller of Examinations, Govt.of India, Ministry of Skill Development and Entrepreneurship, Director General of Training Lr.No.18013/01/ATS/2019/TCC, dt.23.04.2019.

2.Addl.guidelines issued by Deputy Director of Training, Govt. of India, New Delhi vide Lr.No.MSDE-18013/01/ATS/2019-TTC, dt.31.05.2019.

APSRTC has been engaging ITI apprentices as per the provisions of The Apprentices Act, 1961 and other guidelines on the subject from time to time. However, of late several changes have been made and revised guidelines are being issued on the subject by the Govt. with a view to give impetus to training of apprentices in order to improve their skill levels and to make them industry ready.

At present, the ITI apprentices on completion of apprenticeship are appearing for the practical exam to test their proficiency. The entire process of conducting practical exam and declaring results is being taken up by Dept.of Emp. & Trg.(DET), Govt. of A.P.

Vide references 1st & 2nd cited, the Director (TTC), Controller of Examinations, Govt. of India, Ministry of Skill Development and Entrepreneurship, Director General of Training has informed that all establishments registered under Apprentice Training Scheme are allowed as self examination centre for practical exam in AITT (All India Trade Test) for their own apprentices. The evaluation of practical exam may also be done by their own examiner with own question paper. A competent technical person working in the establishment may be appointed as Examiner. The establishments to submit the marks secured by individual candidates to the concerned Apprentice Adviser for processing and declaration of the results. He has enclosed detailed guidelines for conduct of practical exam according to which:-

1. The All India Trade Test (AITT) of Apprentices under Apprenticeship Training Scheme (ASTS) will be held twice in a year in the month of April/May and Oct/November for apprentices registered in establishment under Apprenticeship Act, 1961.

- 2. The following Apprentices are eligible to appear in the AITT:
 - (i) Apprentices who are registered on apprenticeship portal and who has Appeared and failed in previous AITT exams.
 - (ii) Apprentices registered on apprenticeship portal and completed their training on or before 15th April/15th October respectively.
 - (iii) Candidates securing minimum 40% in sessionals theory and 60% in practical exam are only eligible for appearing in AITT.
- 3. All establishments registered under the ATS(Apprentice Training Scheme) are allowed as self examination center for practical exam for their own apprentices and prepare question paper for practical exam as per the following guidelines:
 - (i) A competent technical person in the concerned stream in the establishment may be appointed as Examiner.
 - (ii) The time duration of the practical exam is 6 hours normally. However, where required it can be extended up to 8 hours.
 - (iii) A minimum of 3 questions to be given to the apprentice to attempt in the practicals.
 - (iv) The maximum marks for practical exam is 300. Marks may be allotted depending upon the complexity of skills.

The process of conducting the practical exam and awarding marks has therefore now been delegated to the establishment. In order to conduct practical exams at ZSTC by the ZSTC authorities, common syllabus and related guidelines are required. The same is examined in detail and the syllabus for practical exams to be conducted by ZSTCs has been worked out in respect of 9 trades which are in operation in APSRTC.

The following instructions are issued in this regard:-

1. **Trades**: The Corporation is currently engaging ITI Apprentices in 9 trades. Practical exam to test the proficiency shall henceforth be conducted to the ITI apprentices engaged by the Corporation in the following of trades and marks are to be awarded to the individual candidates.

- 2. Motor Mechanic
- 3. Electrician
- 4.Welder
- 5.Painter
- 6.MW Mechanic
- 7. Machinist
- 8. Sheet Metal Worker
- 9.Draughtsman(Civil)
- 2. **Examiner:** In order to conduct the practical examination to the ITI candidates an examiner with a technical background is to be nominated. The practical exam shall be conducted by the authorities given below:

- 3. **Exam Venue:** The Dy.CME of the Region shall conduct the practical test either at the Regional Headquarters Depot or Zonal Workshop depending upon his/her convenience. The Dy.EE(Civil) may conduct the exam for the Draughtsman (Civil) trade at his office.
- 4. **Syllabus:** The detailed syllabus in trade wise for the practical exam is worked out in detail and annexed to this letter. The practical test shall be conducted as per the scheme and instructions pertaining to that trade.
- 5. **Scheme of Practical Test**: In all the trades there are three parts viz Part-A, B & C. In respect of all trades other than Welding the candidate shall be asked to attempt one question from Part-A and two from Part-B. All the three parts are compulsory. In respect of Welder all the questions in part -A, B & C are to be attempted. The scheme of exam broadly is:-

The apprentice shall be given choice in part-A and Part-B and from the given questions he shall be asked to attempt 1 question from Part-A and 2 questions from Part-B.

The duration of the practical exam is 6 hours and the examinee has to complete the given item of test within the prescribed time.

The Dy.CME of the Region and the Depot Manager of the Depot where the candidate is undergoing apprenticeship, shall ensure that the apprentice is trained properly on all aspects of the trade in which he is engaged and more specifically train them well in practical test syllabus.

6. Results: The result of the practical exam shall be tabulated and the marks obtained by each candidate shall be forwarded to the Principals of ZSTCs. The Principals of ZSTCs shall submit the marks obtained by apprentices in practical exam to the concerned RDD for uploading in portal and declaration of results through apprenticeship portal.

The Principals of all Zonal Staff Training Colleges are advised to take note of the instructions above with regard to conduct of practical test for ITI apprentices and take necessary action as per the above guidelines.
