Sub: TRAINING: Imparting of training on Heavy Motor Vehicle (HMV) Driving and Light Motor Vehicle (LMV) Driving at Zonal Staff Training Colleges – Revised Training Fee communicated – Reg.

The Zonal Staff Training Colleges are imparting training to Drivers on HMV and LMV driving to those sponsored by outside institution duly collecting prescribed fee as per Circular at reference 1st cited. Subsequently vide reference 2nd cited, the amount to be collected was revised upwards. Since there is an all round hike in the input costs it has become inevitable to enhance the Training Fee in respect of Drivers sponsored by out side institutions for imparting HMV/ LMV training by APSRTC.

The Competent Authority having examined the matter has accorded sanction with the concurrence of FA&CAO to revise the training fee of HMV & LMV Drivers as detailed below:
