SUB:- DELEGATION OF POWERS – Revision of Delegation of Powers-2014 in respect of Item No.17 and Item No.19 of Section-14 "Medical Matters" - Notification issued - Reg.

As per the existing Delegation of Powers on Medical Matters the powers to direct an employee to outside institutions for treatment and incur necessary expenditure rests with Head Office. Due to this provision all medical cases are being referred to the Corporate office which is leading to delay in sanction of the medical bills. The matter is reviewed and it is decided to delegate the powers to the Executive Directors of the Zones to facilitate quick disposal of the medical cases.

The Competent Authority with the concurrence of FA & CAO has accorded permission for revising the existing powers accordingly in respect of Item No.17 and Item No.19 of Section-14 "Medical Matters" of Delegation of Powers 2014 as notified at Annexure-I enclosed to this Notification, for implementation with immediate effect, pending approval of the Board.

All the concerned authorities are requested to take note of the same and take necessary action accordingly.
